

RELEASE OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT

Important: This is a legal document. You should read and understand this document before signing.

Signing this may significantly limit your rights.

I, _____, am joining as a temporary participant or a group member of the Fat Bottom Girlz Women on Motorcycles Group, on a voluntary basis without compulsion or coercion.

This is effective immediately upon execution, and in consideration of being permitted to participate in any events held by the Fat Bottom Girlz Women on Motorcycles Group, hereinafter referred to as "FBGz, " I, for myself, my heirs, and assigned representatives, do hereby release, waive, discharge and covenant not to sue the FBGz , its members, ride participants, sponsors and agents, and release from all liability for any and all claims including negligence of the FBGz, for loss or damage to personal property, personal injury, accidents or illnesses (including death) arising out of, or related to participation in any such events.

I fully understand and agree that there are dangers and hazards associated with, and inherent to motorcycle riding. I understand that most of the activities I will be participating in will be conducted over public roads, and in various environments, upon which, many hazards are to be expected and may vary from one activity to another. I further understand that these risks cannot be eliminated regardless of the care taken by the FBGz members, guests, or myself. I understand that these dangers and hazards may result in loss or damage to my personal property in addition to, or including, *minor injuries* to myself such as scratches, sprains and bruises; OR *major injuries* such as eye injuries, neck injuries, head injuries, broken bones, partial or complete paralysis, or even my death. I understand I have the option at any point to remove myself from a ride or activity if I feel unsafe due to my own abilities or perceived negligence of others.

It is understood and agreed that I am solely responsible for the protection of my person and my property and I will obey all State Laws as they apply.

It is understood and agreed that as a participant in a FBGz activity, I will maintain a valid Driver License with a proper motorcycle endorsement.

It is understood and agreed that as a participant in FBGz activity, I verify that I am covered by health, medical, limited life insurance, and I understand that should there be no insurance in force, that I am liable for all expenses incurred.

If any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.

This Release shall be binding upon my signature, and my respective heirs, executors, administrators, personal representatives, successors and assigns. This Release shall be subject to and governed by the laws of the State of Florida.

I have read this Release carefully and fully understand this Release. I am freely, knowingly and voluntarily signing and entering into this Release.
